**11/04/42 Minutes of meeting held on 7<sup>th</sup> September 2004**

**11/04/43 Apologies for absence**

**11/04/44 Police report**

Concern was expressed about security at the MOD site in the Parish. A Parishioner had been stopped by a stranger seeking directions to the site. This had been reported to the Police. The MOD site featured on the internet and the Clerk was asked to raise the matter with Sgt Brown to see if there was any follow-up to this incident. The Clerk was also instructed to ask Sgt Brown if, on those occasions when he was unable to attend Parish Council meetings, he would send a report.

**11/04/45 Questions from public**

A question was asked about work that was taking place at Gale Moss. No one seemed to know what was happening. Clerk to make enquiries from neighbouring Parish Councils. (Enquires revealed that work is being carried out by British Waterways. They are laying down a track and fencing it off so that they can transport equipment to carry out repairs to a culvert under the Leeds Liverpool canal).
